

Skyworks Reports Q4 and Full Year FY23 Results

Nov 2, 2023

- Delivers Revenue of \$1,219 Billion
- Posts GAAP Diluted EPS of \$1.52 and Non-GAAP Diluted EPS of \$2.20
- Generates Annual Operating Cash Flow of \$1.856 Billion, Up 30% Year-Over-Year, and Free Cash Flow of \$1.646 Billion, Up 76% Year-Over-Year

IRVINE, Calif.--(BUSINESS WIRE)--Nov. 2, 2023-- Skyworks Solutions, Inc. (Nasdaq: SWKS), an innovator of high-performance analog and mixed signal semiconductors connecting people, places and things, today reported fourth fiscal quarter and fiscal year-end results for the period ended Sept. 29. 2023.

Revenue for the fourth fiscal quarter of 2023 was \$1.219 billion. On a GAAP basis, operating income for the fourth fiscal quarter was \$254.0 million with diluted earnings per share of \$1.52. On a non-GAAP basis, operating income was \$397.9 million with non-GAAP diluted earnings per share of \$2.20.

"Skyworks delivered solid results despite macroeconomic headwinds reflecting our resilient business model and operational excellence," said Liam K. Griffin, chairman, chief executive officer and president of Skyworks. "We generated record free cash flow well above \$1.6 billion for fiscal 2023, increasing 76% year-over-year. In light of the cycle volatility, we continue to make strategic investments in growth areas, expanding our customer base and diversifying the reach of our business."

First Fiscal Quarter 2024 Outlook

We provide earnings guidance on a non-GAAP basis because certain information necessary to reconcile such guidance to GAAP is difficult to estimate and dependent on future events outside of our control. "We expect revenue to be \$1.175 to \$1.225 billion in the December quarter," said Kris Sennesael, senior vice president and chief financial officer of Skyworks. "At the mid-point of the revenue range, we anticipate non-GAAP diluted earnings per share of \$1.95. We expect our mobile business to demonstrate momentum, while in broad markets we expect to continue to digest excess inventory in select segments, affecting our revenue outlook."

Dividend Payment

Skyworks' board of directors has declared a cash dividend of \$0.68 per share of the Company's common stock, payable on Dec. 12, 2023, to stockholders of record at the close of business on Nov. 21, 2023.
