Bluetooth™ or Multimedia messaging is also available for sending video, pictures, music and text. The W810 incorporates the SKY77329, a PA module designed in a compact form factor for quad-band cellular handsets. With its custom CMOS integrated circuit, the module provides the internal PA control function and interface circuitry, providing envelope amplitude control by reducing sensitivity to input drive, temperature, power supply and process variation.
